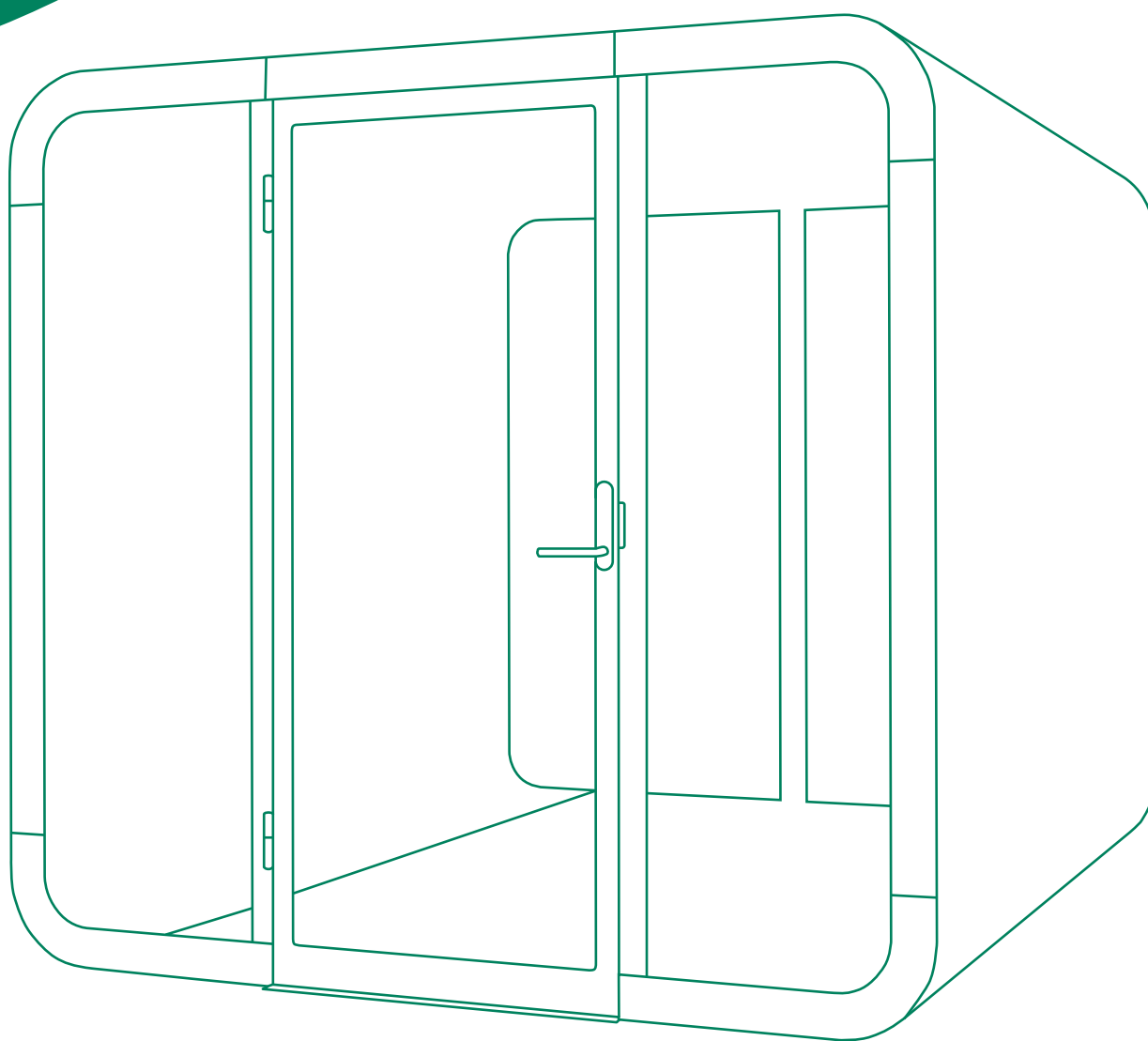

1 Important safety and product instructions

1.1 Preface

This instruction manual describes the use of the product. Everyone involved in using the product must read and understand the contents of the user and safety instructions.

This instruction manual gives you necessary information for the correct use.

All product instructions are also available at help.frameryacoustics.com.

1.2 Product information

The information in this manual corresponds to the product at the time of delivery. All information included in this manual is valid at the time of publication.

1.3 Copyright

This document must not be copied, presented, or delivered to a third party without explicit permission from Framery. The use of this document for any purpose other than those allowed by Framery is prohibited. Framery reserves the right to change the instructions related to the product without separate notice.

1.5 Intended use

The Framery 2Q is a pod intended for short term indoor commercial and household use by one to six (1-6) people at a time.



Warning: WARNING –To reduce the risk of burns, fire, electric shock, or injury to persons:

Use this product only for its intended use as described in the user instructions. Do not use attachments not recommended by the manufacturer.

1.5.1 Non-conventional use

Any use or maintenance of the product that is not specifically allowed in the installation, maintenance, troubleshooting or user instructions is prohibited, including the following:

- Installation, maintenance or disassembly of the pod without reading and understanding the instructions for those actions
- Use of the pod beyond the limits of use
- Making alterations to the pod

- Using the pod in spite of obvious defects or damage
- Using the pod outdoors or in conditions where the temperature or air quality is not safe
- Climbing on top of the product or placing any load on the roof of the product
- Smoking in the pod

1.5.2 Ambient conditions for use

The pod is intended to be used in the following conditions:

- Ambient temperature: +15°C ... +30°C (59°F ... 86°F)
- Humidity: max. 50%
- Sufficient air quality surrounding the product

1.6 Warning, information, and safety symbols in this manual

The warnings in this manual have been divided into the following two categories:

- The term "DANGER" indicates a hazardous situation which, if not avoided, will result in death or serious injury.
- The term "WARNING" indicates a hazardous situation which, if not avoided, could result in death or injury.

The safety symbols found in this manual may also be posted on the product. All personnel who install, disassemble, perform maintenance, or use the product are to be familiar with and observe all safety symbols, labels, and instructions about the action they are performing.

1.7 Main safety risks related to the installation, maintenance, disassembly, and use of the product



1.7.1 Installation, maintenance, and disassembly








	<p>WARNING!</p> <p>To reduce the risk of burns, fire, electric shock, or injury to persons, obey the following:</p>
	Use cut resistant safety gloves during the installation, maintenance, or disassembly of the product.
	Use steel toed safety boots during the installation, maintenance, or disassembly of the product.
	Use safety glasses during the installation, maintenance, or disassembly of the product.
	Read and understand the instructions and plan your work beforehand.
	Obey all local rules and regulations regarding workplace safety.
	Keep the work site tidy and free from debris throughout the installation, maintenance, or disassembly process.
	Do not climb on top of the product or place any load on the roof of the product.
	<p>Do not push the the finished product to move it without engaging the optional casters.</p> <p>The product is very heavy and moving the product after installation without engaging the optional casters requires a significant amount of force. Moving a finished product (not using the optional casters) without disassembly and reassembly requires an on-site risk assessment to be performed by the party responsible for moving the product.</p>

1.7.2 Electrical safety

Input for the electrical system: 100-240 VAC (10 A) 50-60 Hz



The maximum load for the electrical system is 6.6 A.

	<p>DANGER!</p> <p>To reduce the risk of electric shock, obey the following:</p>
	<p>Disconnect the power cord from the power outlet before starting any cleaning, maintenance, or disassembly procedures.</p> <p>The power cord serves as a power disconnect device for pluggable equipment. The power outlet shall be located near the equipment and shall be easily accessible.</p>

	<p>WARNING!</p> <p>To reduce the risk of burns, fire, electric shock, or injury to persons, obey the following:</p>
	Connect the power cord to a properly grounded outlet only.
	<p>This product is for use on a nominal 120-volt circuit and has a grounding plug that looks like the plug illustrated in the figure below. 	Keep the power cord of the product away from heated surfaces.
	Do not use the pod if you notice any defects or damage to the electrical equipment.
	Do not connect any extension cords to the power outlet(s) of the product.

1.7.3 Fire safety

The fire load for the Framery 2Q is approx. 10400 MJ.

	<p>WARNING!</p> <p>To reduce the risk of burns, fire, electric shock, or injury to persons, obey the following:</p>
	<p>If safely possible to perform, disconnect the power cord from the power outlet if there is a fire inside the product.</p> <p>The power cord serves as a power disconnect device for pluggable equipment. The power outlet shall be located near the equipment and shall be easily accessible.</p>

Fire safety end devices (alarms, sprinklers etc.) can also be installed inside the pods (instructions available upon request). The need for end devices inside the pod is always determined by the applicable local authorities.


1.7.4 Use

Maximum loads for the 2Q table options:

- Huddle table: 131lbs (60 kg)
- Lounge side table 33 lbs (15 kg)
- Lounge piaggio table: 78 lbs (35 kg)


Maximum loads for Framery 2Q seats:



- Lounge back sofa: 900 lbs (408 kg)
- Lounge side sofa: 900 lbs (408 kg)









 **Note:** Framery does not supply seats for the 2Q Huddle.

Maximum load for the display bracket is 65 lbs (30 kg).

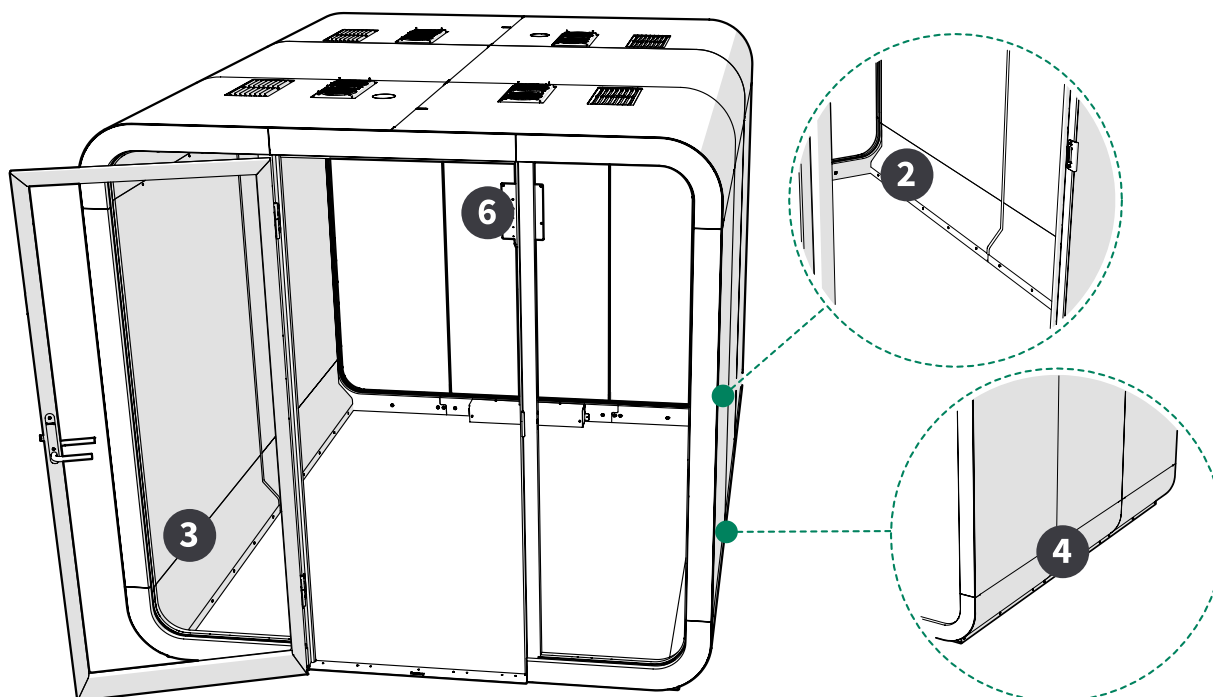
Maximum load for the 2Q Lounge whiteboard bracket is 33 lbs (15 kg).

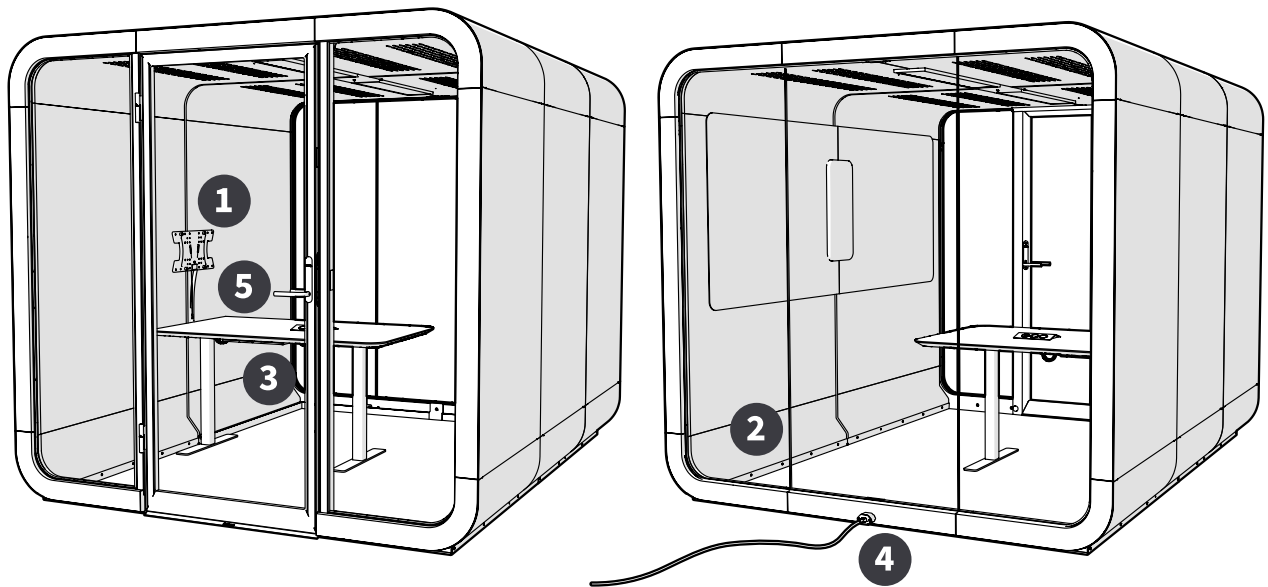
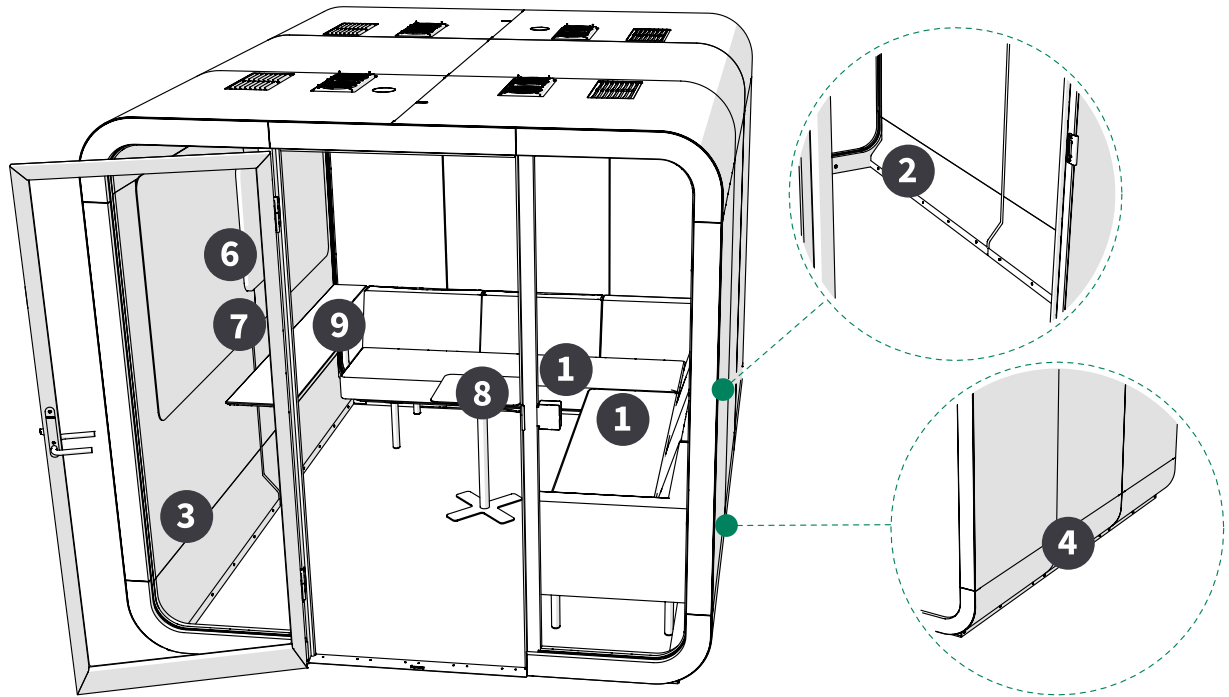



	Do not use where aerosol (spray) products are being used or where oxygen is being administered.
	Do not climb on top of the product or place any load on the roof of the product.
	Do not lean against the product.
	Do not smoke inside the product.
	Do not obstruct the view through the front and back glasses by posting signs, decorations, or by installing blinds or draperies that would prevent occupants from seeing the visible alarm appliances located in the structure where the pod is installed.






2 Entering the pod

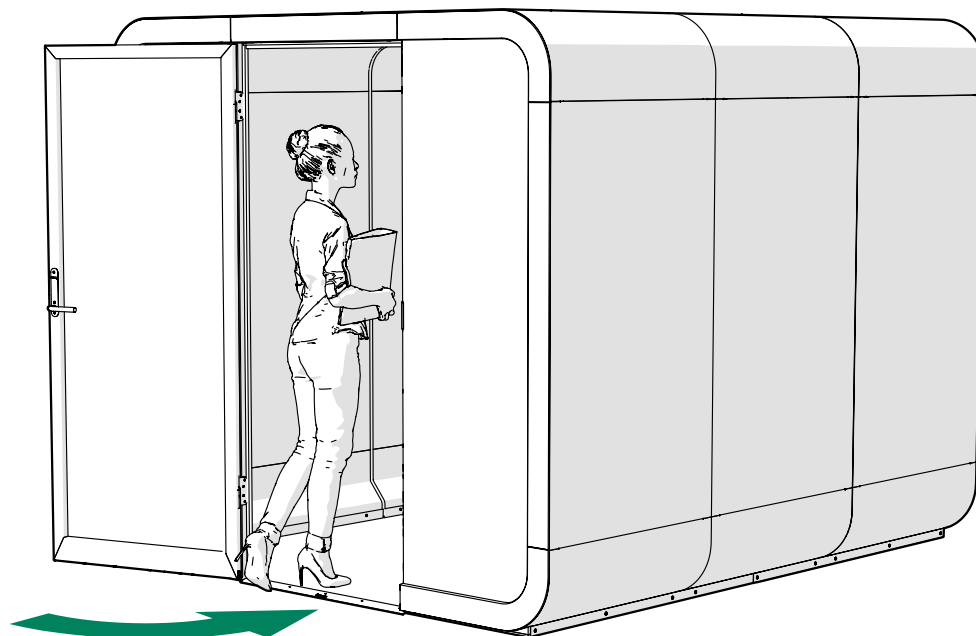
1. Push down on the door handle.



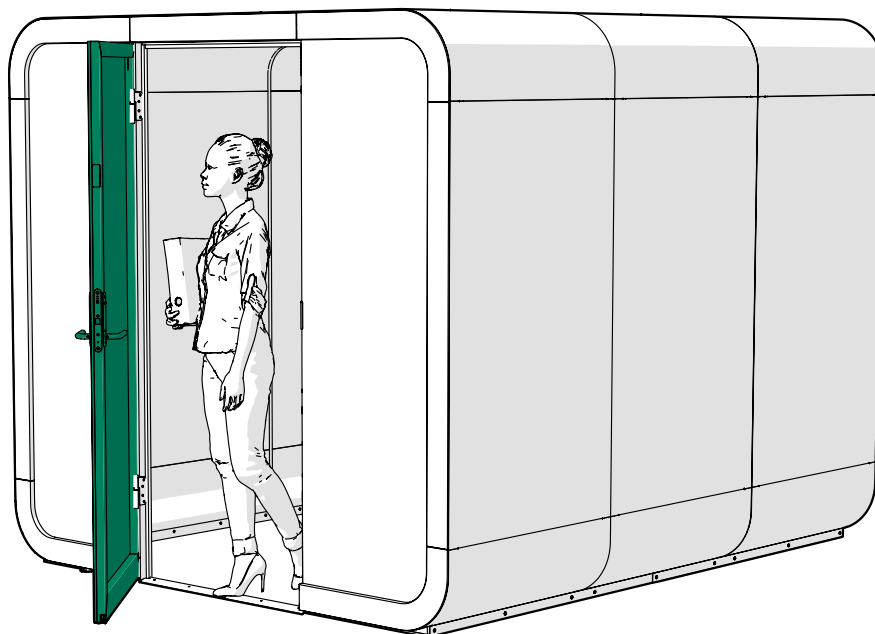
2. Pull the door open.



3. Enter the pod.

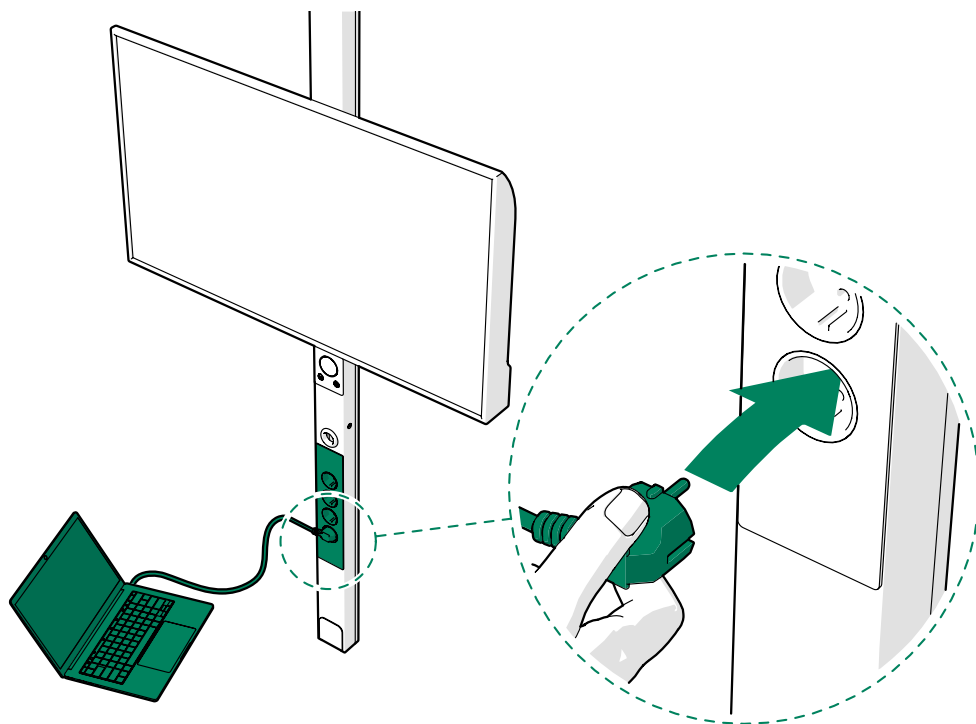


4. Pull the door shut.

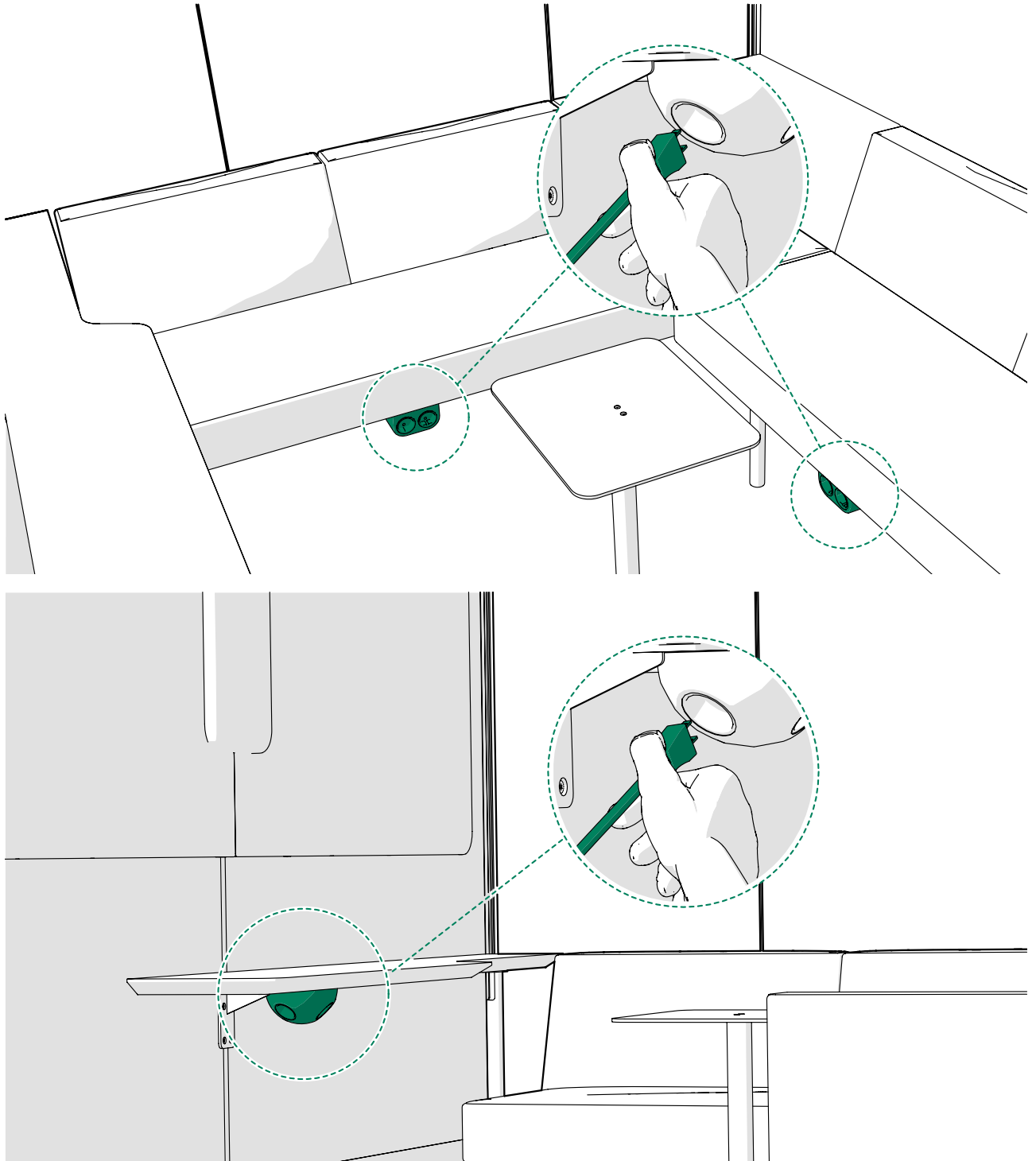


3 Connecting electrical equipment

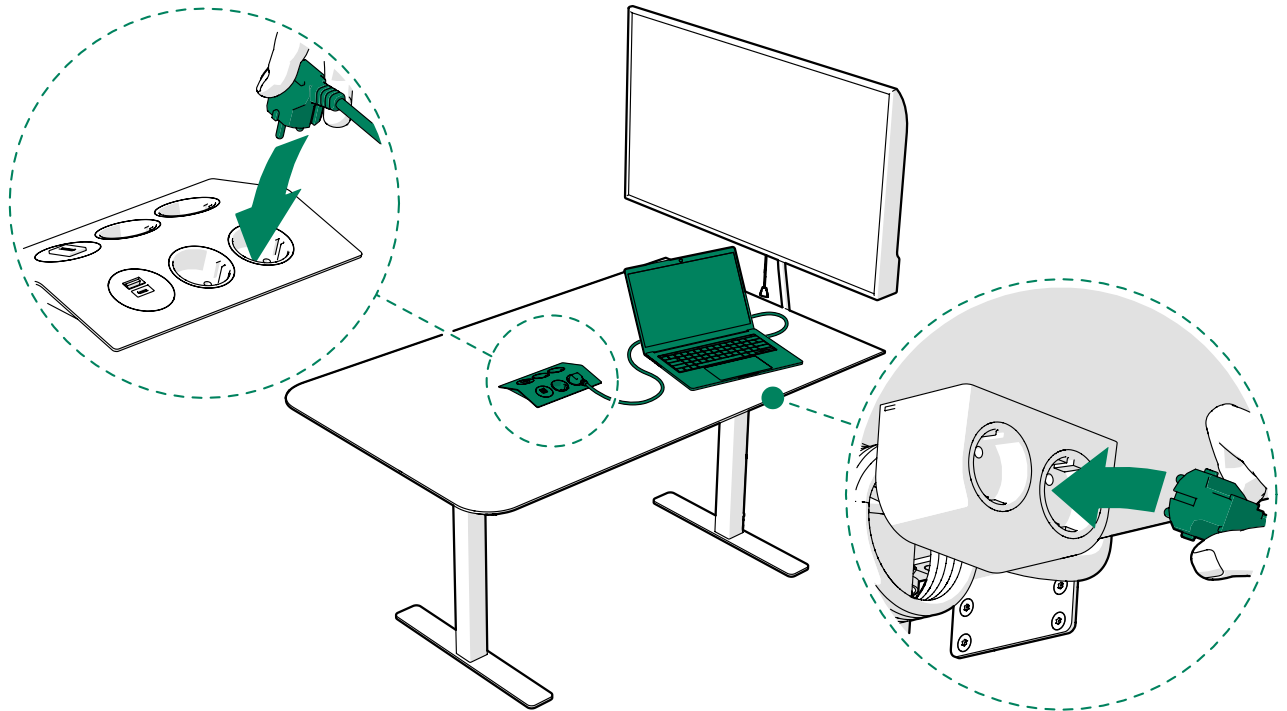
1. In 2Q Without furniture, connect the power cord plug of your device to the power outlet on the power column.



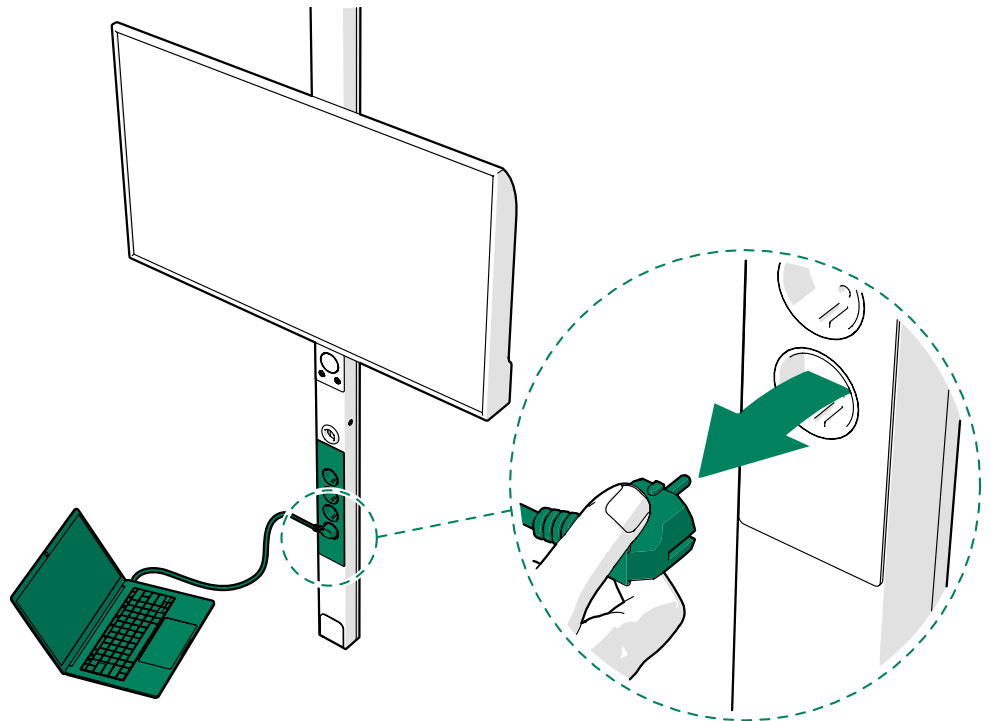
2. In 2Q Lounge, connect the power cord plug of your device to one of the power outlets under the sofa or to the outlet under the side table.



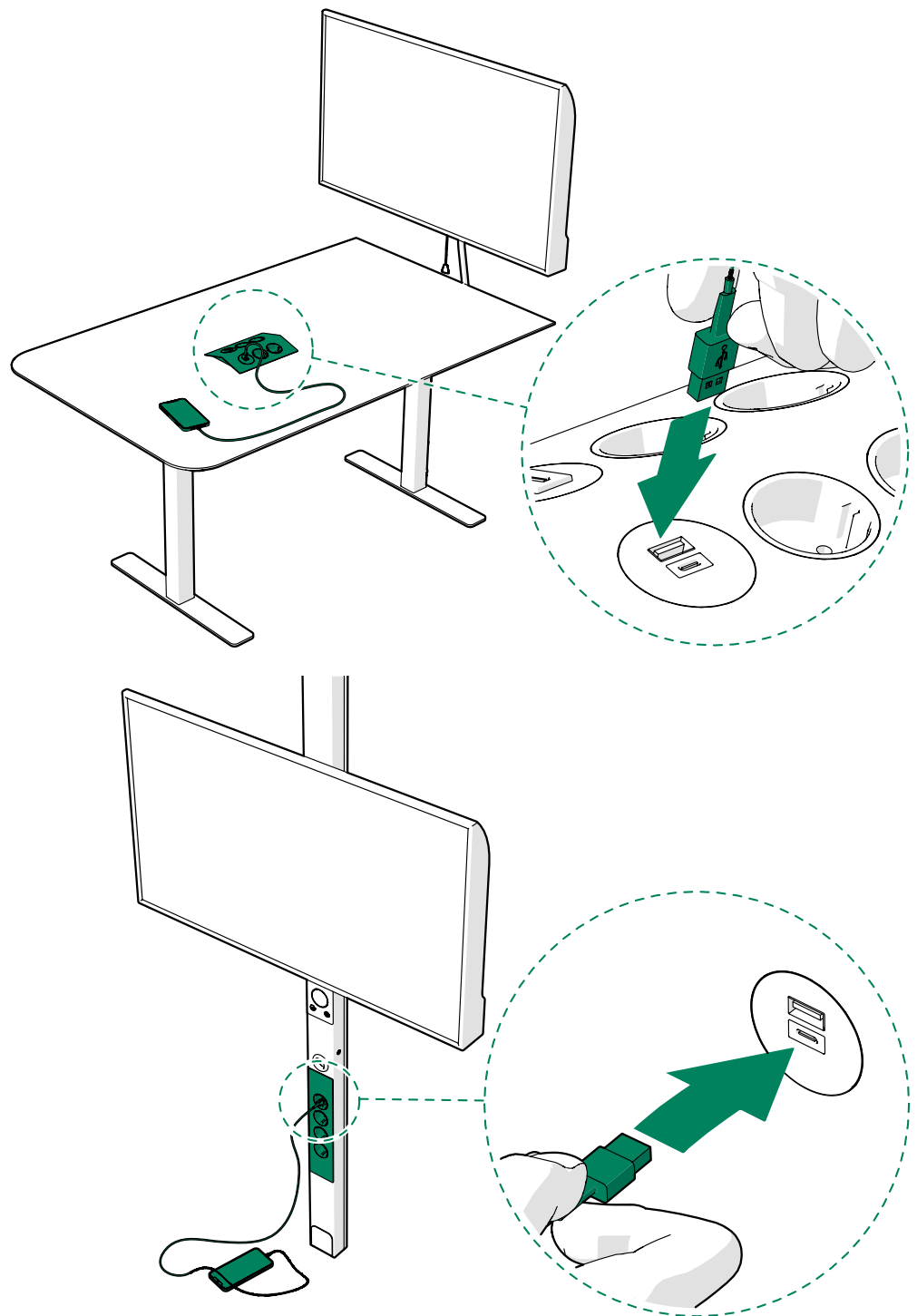
3. In 2Q Huddle, connect the power plug to the power outlet on the table or to the outlet under the table.



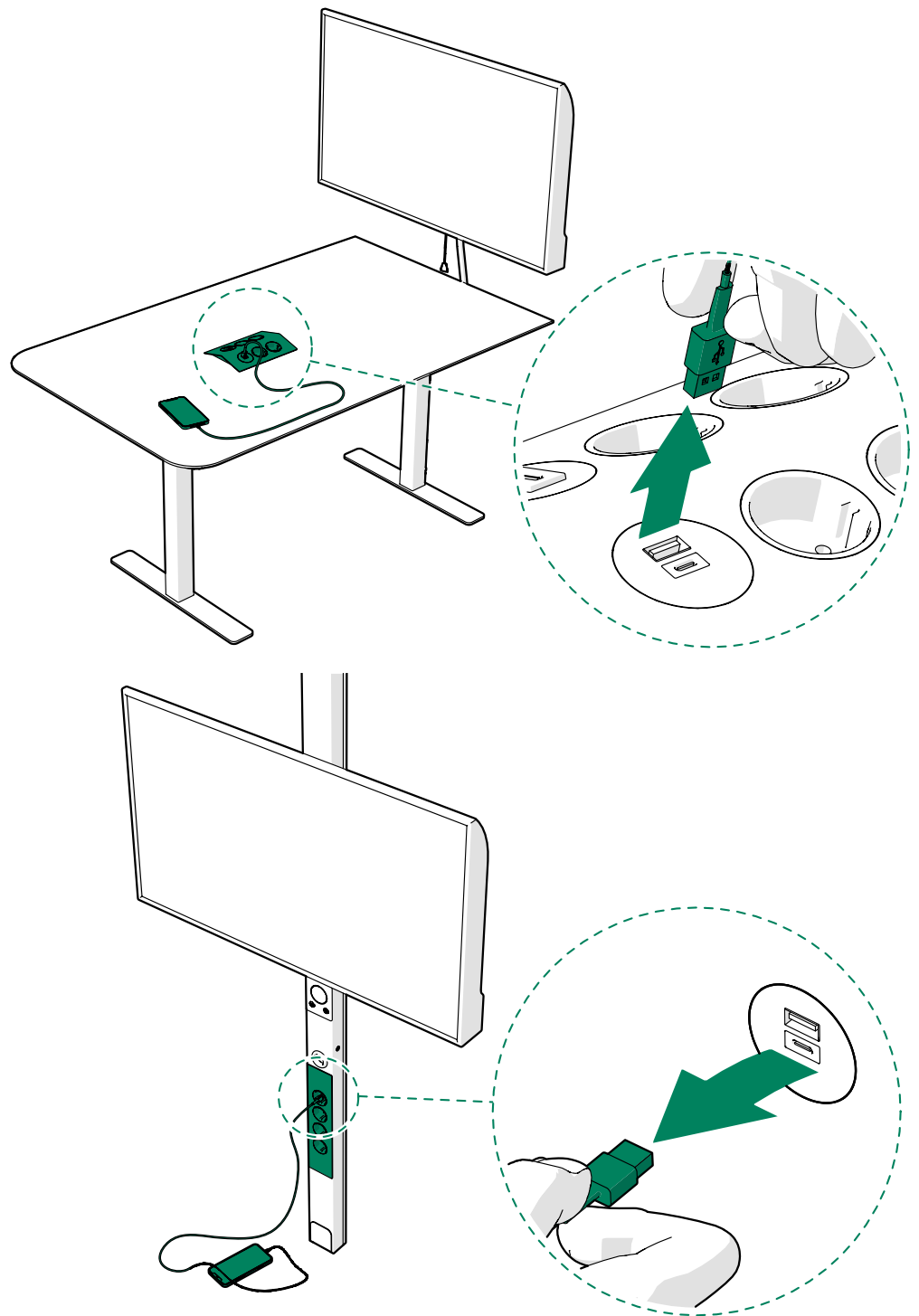
4. To disconnect your device, remove the power cord plug of your device from the power outlet.



5. To connect USB-powered devices, use the USB connector of the power outlet on the table (Huddle interior), on the power column (Without furniture interior) or under the side table (Lounge interior).



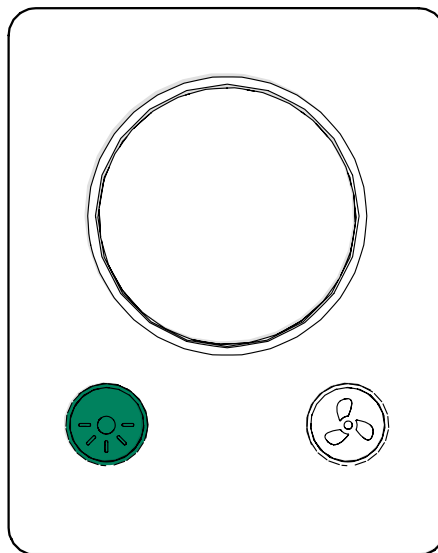
6. To disconnect your USB-powered device, remove the usb cord from the connector.



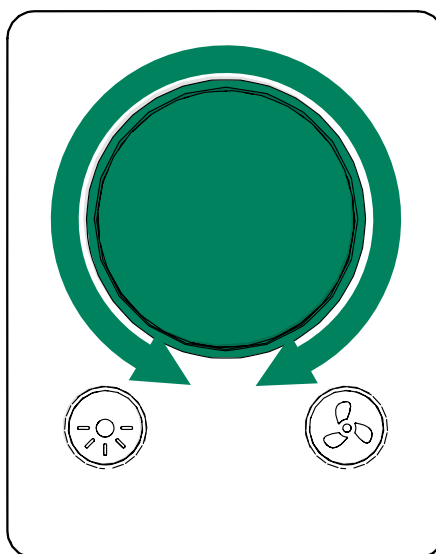
4 Using the control panel

4.1 Adjusting the lights

1. Push the light button on the control panel to enable adjustment.

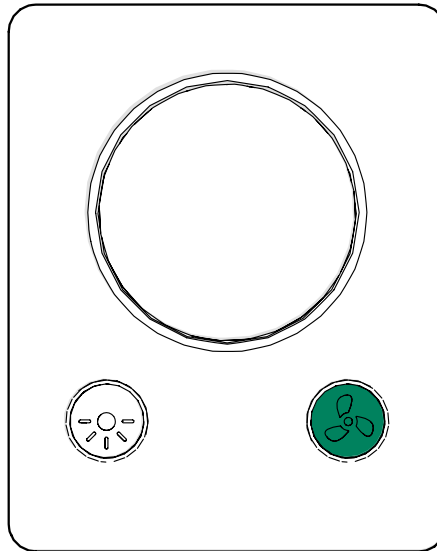


2. Rotate the control disc clockwise to brighten and counter-clockwise to dim the light.

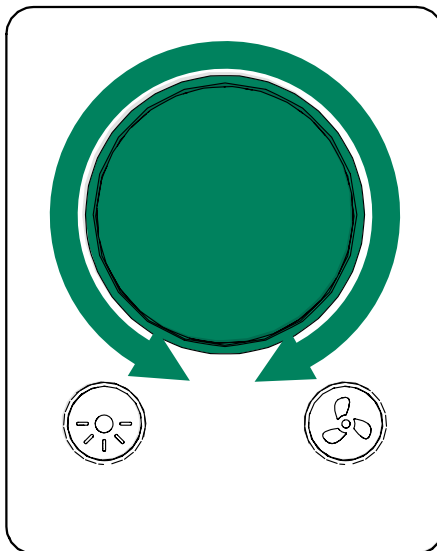


4.2 Adjusting the fans

1. Push the fan button on the control panel to enable adjustment.



2. Rotate the control disc clockwise to accelerate and counter-clockwise to slow down the fans.



5 Connecting your laptop to the display

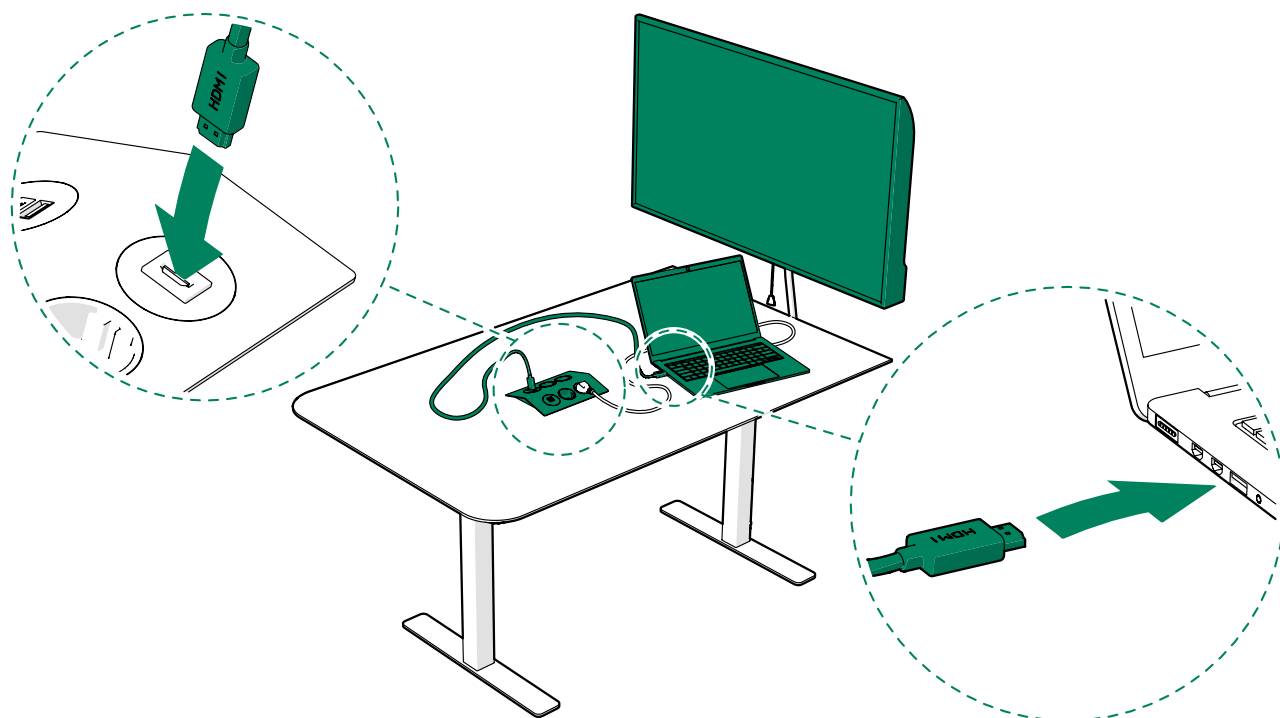
 **Note:** The pod may not be equipped with a customer supplied display.

In 2Q Without furniture, the customer supplied display is mounted on the power column at the back of the pod. The HDMI cord is connected to the display and the other end is available to be connected to your laptop.

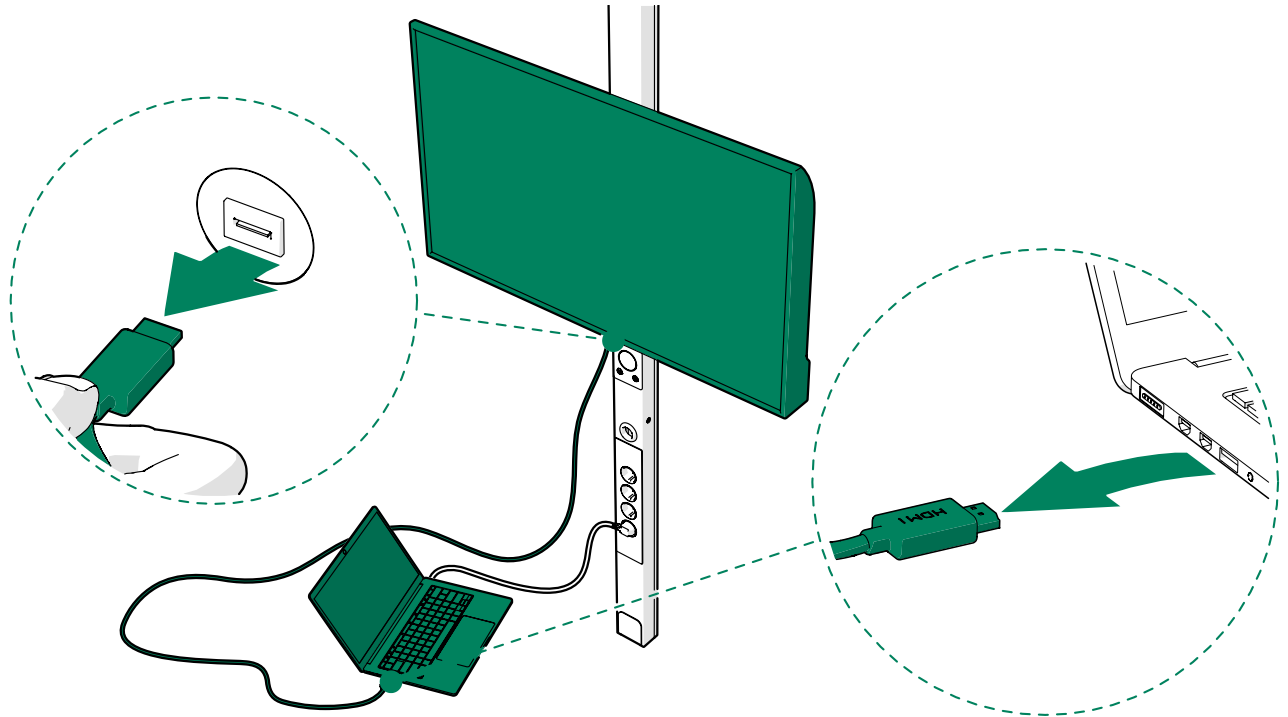
In 2Q Lounge, the customer supplied display is mounted on the wall. The free end of the HDMI cable is available to be connected to your laptop at the side table.

In 2Q Huddle, the customer supplied display is mounted on the wall. The display is connected to the HDMI connector of the power outlet on the table.

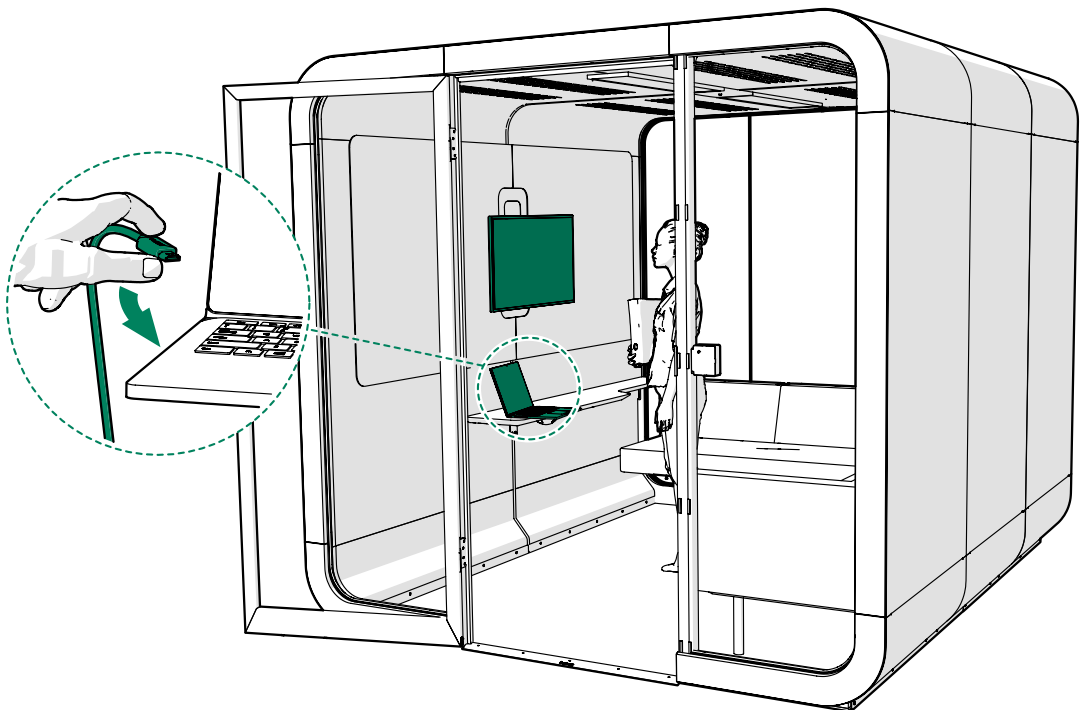
1. In 2Q Huddle, connect one end of an HDMI cable to the HDMI connector in the table power outlet and the other end to your laptop.



2. In 2Q Without furniture, connect the free end of the HDMI cable from the display to your laptop.



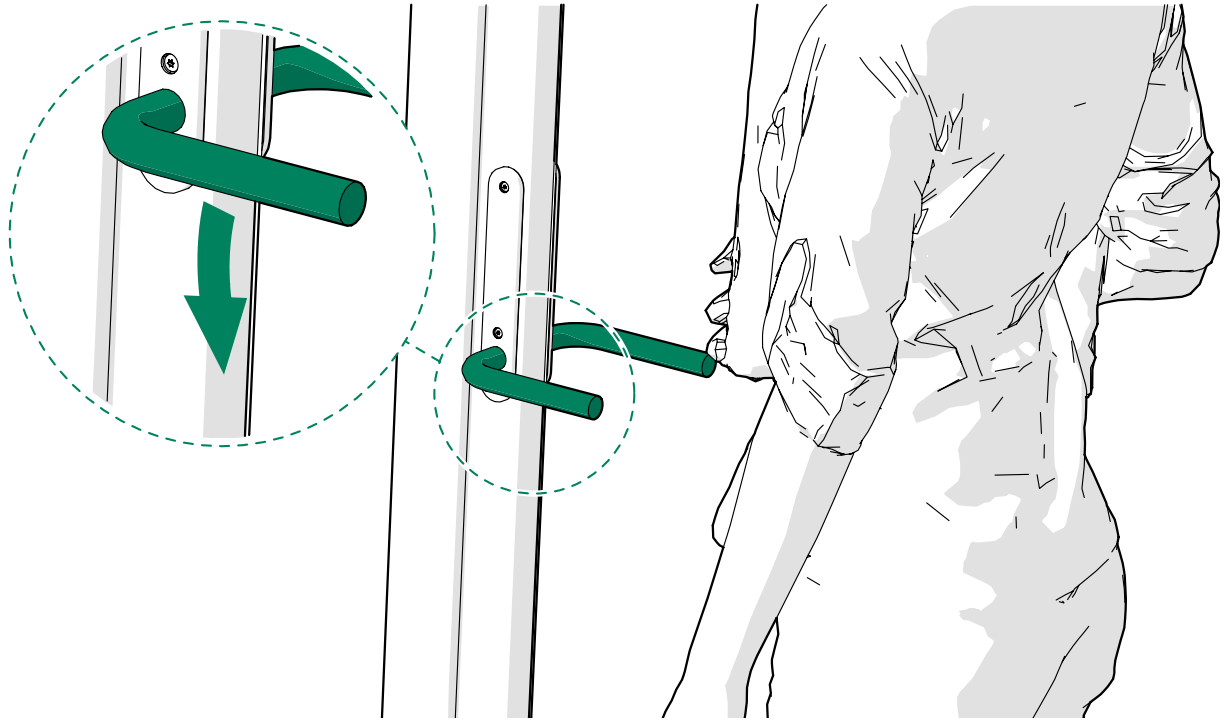
3. In 2Q Lounge, connect the HDMI cable at the side table to your laptop.



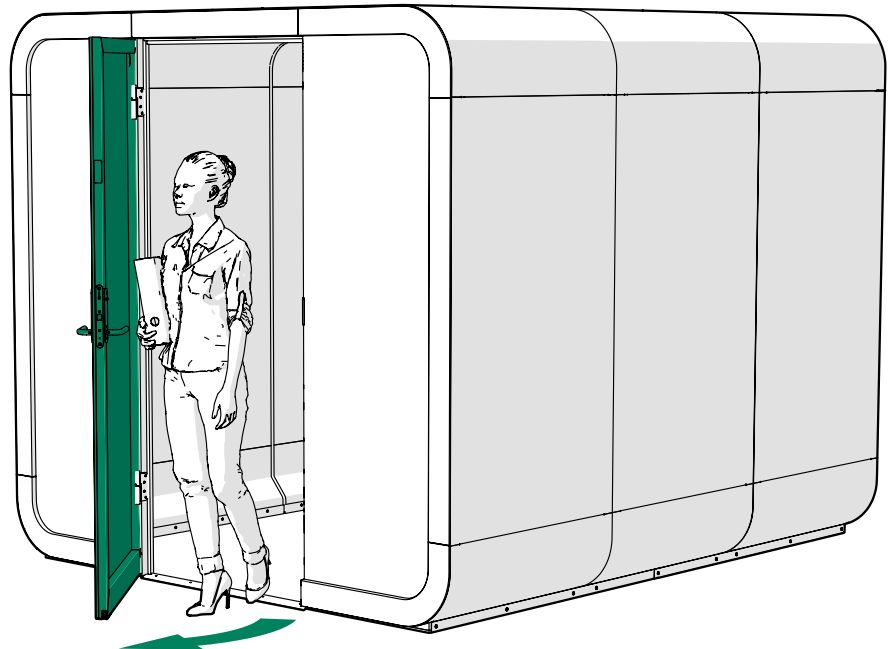
4. If equipped with the optional LAN cable, connect the LAN cable to your laptop.

6 Exiting the pod

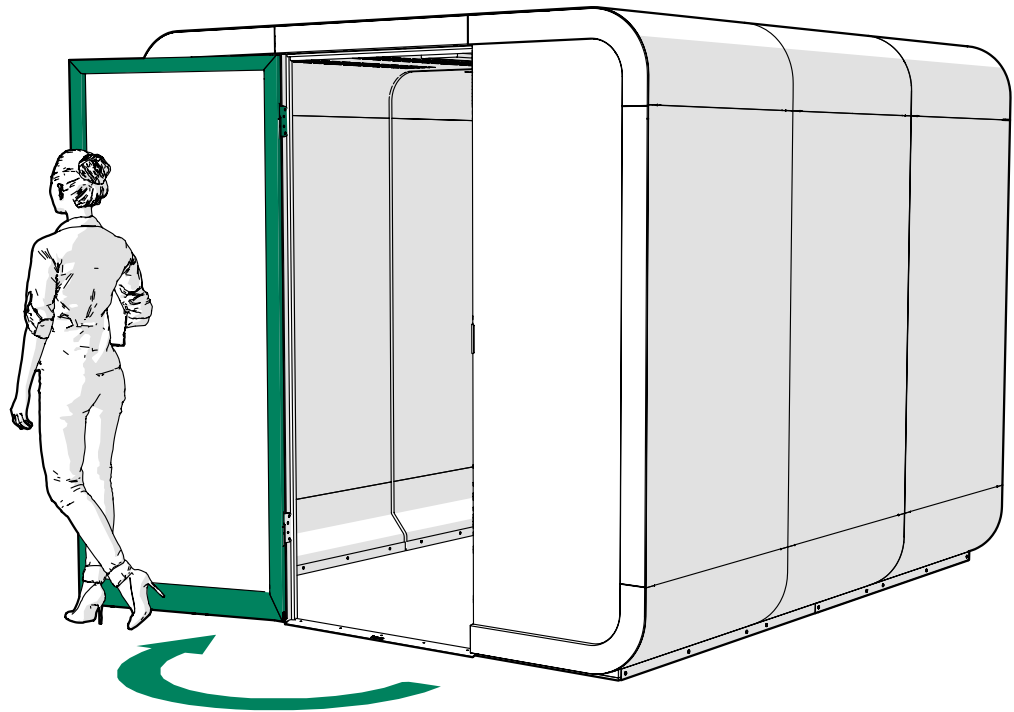
1. Push down on the door handle.



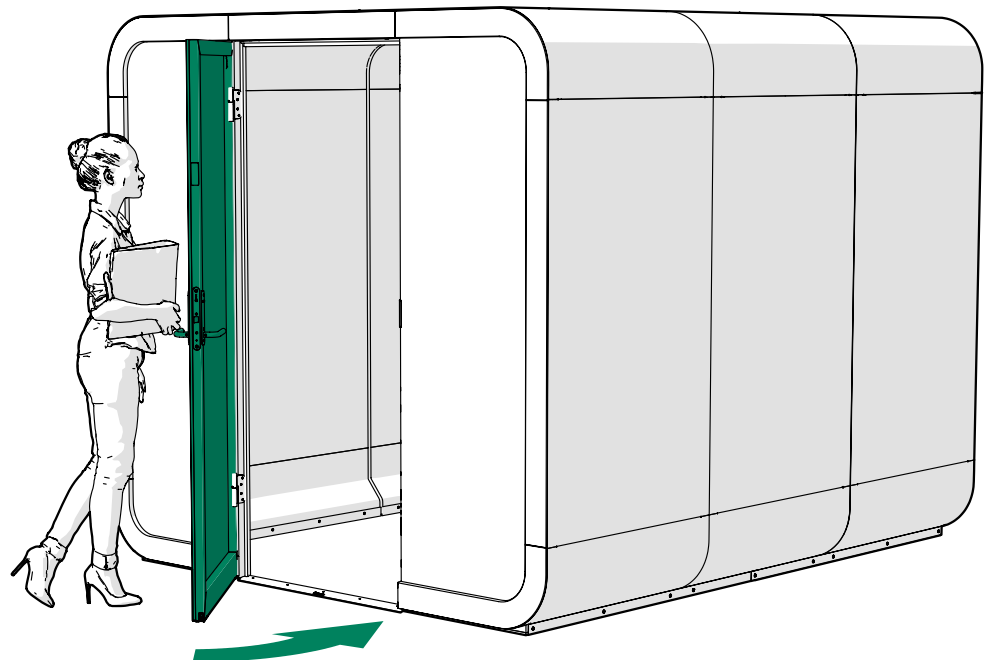
2. Push the door open.



3. Exit the pod.



4. Push the door shut.



7 Using the optional whiteboard

7.1 Daily cleaning

Wipe the whiteboard with a microfibre cloth.



Note: Clean and replace the cloth regularly.

7.2 Deep cleaning

Clean the whiteboard carefully. Use water and a microfibre cloth. If the whiteboard is unusually dirty or stained, use a mild alcohol-based cleaning solution.



Note: Never use a soap-based solution.

After cleaning, make sure that the whiteboard is completely dry. Moisture impairs writing on and erasing the text on the whiteboard.

7.3 FAQ

Someone has used a permanent marker on the whiteboard. How do I remove it?

Use water and a microfibre cloth. If this is not sufficient, try using a mild alcohol-based cleaning solution.



Note: Never use a soap-based solution. It may damage the whiteboard.

I have cleaned the whiteboard according to recommendations, but erasing is still difficult.

Whiteboard pens have varying quality. Try to change to another brand. If you replace a pen, also replace the eraser cloth.
